ABC wants checks 45 days prior to the 1<sup>st</sup> of the month on your expiration date. That means that we MUST receive your check at least 60, preferably 90, days prior to your renewal date to make sure that you don't miss any magazines. I will try to post renewals 3 months in advance. Remember, you can renew for up to 3 years at a time. I would highly recommend this option so that you don't miss any magazines. GMBC prices have been raised as of January 2005 to \$35 full and \$10. So, please take note. This reflects increases by ABC and for insurance, postage, etc.

2 years = \$70    Assoc. = \$20  
3 years = \$105    Assoc. = \$30
