The list above is current according to ABC records. (updated 1/1/10 for ABC 3rd quarter 9/09). ABC would like your check **45 days prior to the 1st of the month** on your expiration date. This means that we must receive your check at least 60, preferably 90, days prior to your renewal date. This will make sure that you don't miss any magazines.

I will try to post renewals 3 months in advance. Remember, you can renew up to 3 yrs. at a time. I would highly recommend this option so that you don't miss any magazines.

GMBC prices were last raised as of January 2005 to \$35 full and \$10 assoc. (please note). This reflects increases by ABC and also increases for insurance, postage, etc.

2 years = \$70    assoc. = \$20

3 years = \$105    assoc. = \$30

## Greater Milwaukee Brittany Club Meeting minutes from September 30th 2010



Our Annual General Meeting for the Greater Milwaukee Brittany Club was held at Gander Mountain, Franklin WI. The meeting was called to order by Club President Sam Thompson at 6:40 p.m.

**Secretary's Report:** The meeting held on July 17th 2010 was presented and read by Secretary Jeff Jarmuskiewicz. A motion to approve was made by Andy Lewandowski and seconded by Julie Asmus.

**Treasury Report:** Dave presented the balance of the treasury. New financial forms will be created for events. The new forms will be a standard report that all event chairs will need to give to Dave.
